What do we do?

With the digital platform of iAccess Partners you can invest in Private Equity funds starting with a minimum investment amount of **25'000 Swiss Francs**. Private Equity funds used to be only accessible to institutional investors (e.g. 75% of all Swiss pension funds are partly invested in Private Equity) and

high-net-worth individuals, who were able to invest millions of Swiss Francs into a single Private Equity fund. By **aggregating smaller investment amounts** into a larger investment ticket, iAccess Partners gives access to Private Equity funds.



How do we do it?

For you to gain access to a Private Equity fund, your investment needs to be aggregated with the investments of other investors, in order to have a large enough investment sum, which allows for the investment into a Private Equity fund. iAccess Partners' fully digital investment platform efficiently aggregates the individual Private Equity fund investments. Depending on the Private Equity fund investment opportunity, you either invest directly into the Private Equity fund or you invest in a Private Equity fund via a special purpose vehicle (SPV). For each Private Equity fund investment opportunity, iAccess Partners transparently outlines if the investment is done directly in a Private Equity fund or via an SPV.
